Best and Worst Trends for the Family in 2016 Best

1. Slovenians Reject Same-Sex "Marriage" by a landslide vote – Citizens of Slovenia repealed an SSM law passed by their legislature. Opponents of the law collected over 40,000



signatures to put a repeal measure on the ballot, In October, the nation's Constitutional Court ruled the National Assembly couldn't block the referendum. On December 21, the first gay marriage law in Eastern Europe was repealed by a vote 63.5%. Former Prime Minister Janez Jansa stated the obvious, "It is not possible to build the future of Slovenia with same-sex couples." Like most of the region, Slovenia has well-below replacement fertility. "Sexual equality" may be a heady elixir for the elite, but can't fill empty cradles.



2. U.S. Congress Votes to De-fund
Planned Parenthood – In mid-December,
for the first time, both houses of Congress
voted to eliminate funding for Planned
Parenthood, whose clinics perform over
320,000 abortions annually. The outcry
over the sale of fetal tissue spurred the
vote. (Managers at PPF clinics were caught
on camera chortling over the money they
could make by selling body parts.)
Majorities in both Houses decided they
could find better things to do with an

annual appropriation of \$528 million – like giving it to thousands of community-based health centers. For Planned Parenthood, casting itself as a champion of women's rights was always a tough sell. More so now, with the awareness that it trades in the organs of its victims.

3. Hungary and Poland block covert effort to enact SSM throughout the EU

Proponents of marriage deconstruction tried to get the EU Council to approve a proposal which would have required nations without gay "marriage" to recognize such unions contracted elsewhere. If enacted, the government of Slovenia, whose voters just rejected SSM by an

overwhelming margin, would have been forced to recognize such a travesty contracted in Western Europe. Since the measure required unanimity of member states, Hungary and Poland were able to kill it. Not that proponents won't keep trying. When democracy fails them, as it usually does, and courts decline to override the will of the people, bureaucratic subterfuge is their last resort.

- **4. EU Parliament Condemns all forms of Surrogacy** In a resolution that passed just weeks ago, the EU Parliament condemned surrogacy, "which undermines the human dignity of the woman since her body and its reproductive functions are used as a commodity." The free market is great, but not when it turns women into incubators for hire.
- 5. Anglican Bishop of Sydney says Marriage has boundaries – In opening a 2015 synod, Dr. Glenn Davies, Anglican Archbishop of Sydney, Australia, noted that "The antagonism of the world to the word of God is perhaps



seen nowhere more acutely than in the virulent challenges to the definition of marriage." Davies questioned the notion of marriage equality, reminding listeners: "There is simply no marriage equality for everyone. Marriage necessarily has boundaries that even the adherents of the facile rhetoric of 'marriage equality' can not deny." This includes "marriage" by blood relatives, under-aged partners, and multiple partners. In other words, everyone draws the line somewhere, which means, regarding marriage, everyone discriminates to one degree or another.

6. British Parliament overwhelmingly rejects assisted suicide – On September 11, the British House of Commons, the Mother of Parliaments, rejected a bill to legalize assisted suicide in certain cases by a vote of 330 to 118. Dr. Philippa Whitford, MP, a breast cancer surgeon, told her colleagues, "I have never considered as a doctor that death was a good treatment for anything."

7. Thousands rally in Rome against gender ideology – On June 24, an estimated 300,000 rallied in Rome against the introduction of gender ideology in Italian schools. This dogma, dear to the hearts of sexual radicals

- everywhere, holds that gender is an artificial construct rather than a biological imperative determined at birth. Simone Pillon of Family Forum told the crowd, "Today in this square, we are all creating a culture, not against persons, but against ideologies that are destroying the family and are trying to destroy man and woman as its model." Who can say where gender theory may lead. Perhaps *species* is also an artificial construct and oppressive to those creatures artificially labeled cats and dogs.
- 8. Parade in Korean county with nation's highest fertility rate Along with most developed nations, the Republic of Korea has a depressingly low fertility rate a national average of 1.2, roughly half of replacement level. In the 1970s and '80s, the government launched anti-fertility drives which succeeded all to well. Now the nation is desperate to reverse the trend. With free baby clothes and monthly cash allowances, Hanam, a rural county on the tip of the Korean peninsula, has achieved the nation's highest fertility. On November 4, it celebrated the distinction with a parade of visibly pregnant women and those pushing baby carriages and leading toddlers. It's ZPG's worse nightmare, but may just be the nation's salvation. As a 37-year-old who just had her third child remarked, "Babies are the hope for the family and the nation."
- 9. Senior physician in British National Health Service wants women educated on fertility When feminists talk about empowering women, they mean telling them how to get an abortion. Professor Geeta Nargund, a gynecologist consulting with the British National Health Service, has something else in mind. In a letter to Education Secretary Nicky Morgan, Nargund urged fertility education. "I have witnessed all too often the shock and agony on the faces of women who realize they have left it too late to start a family," Nargund wrote. "Information is power and the best way to empower people to take control of their fertility is through education." Facilitating conception instead of abortion, what will they think of next?
- 10. Chief Justice of the Alabama Supreme Court Tells Probate Judges to Stop Issuing Marriage Licenses to Same-Sex Couples Roy Moore, Chief Justice of the Alabama Supreme Court, enjoined the state's probate



judges from issuing licenses to same-sex couples. The Chief Justice noted that in a 2006 referendum, Alabama amended its constitution – with a yes vote of 81% – to define continued on page 3

marriage as the union of a man and a woman. Why then should our state bow to the whim of five members of the Supreme Court, overturning 3,300 years of Western civilization, he asks? Just say no to judicial tyranny?

Worst

1. US Supreme Court In Effect Abolishes Marriage - In

1973, the Supreme Court found a nonexistent right to abortion lurking in the penumbra of an equally non-existent right to privacy in the First Amendment. In June, by a single



vote, SCOTUS invented another fictitious right (that of men to marry men and women to marry women) – this notwithstanding that 32 states amended their constitutions between 1998 and 2012 to limit marriage to a man and a woman. In reporting the ruling, the mainstream media said the Supreme Court created a constitutional right to same-sex marriage. But government doesn't create rights. It can either affirm or deny them. In this case the latter. Here, by a one-vote majority, in a flight of egalitarian fancy, SCOTUS constructed a right out of thin air. Chief Justice John Roberts said the ruling "has no basis in the Constitution." In positing a phony right, the decision denied a real one– that of children to grow up in a home with a mother and a father.

- 2. Ireland's bait and switch on gay "marriage" It took less than six months for proponents of SSM in Ireland to break a solemn promise. Ireland's gay "marriage," referendum, which passed overwhelmingly in May, included protection for freedom of conscience on religious grounds. There were exemptions for Catholic institutions, including schools and hospitals. Many voters relied on those protections when they voted for the measure. In December, the Irish parliament stripped away the safeguards. Proponents of marriage "equality" are totalitarians. Coercion is necessary for their agenda to succeed.
- 3. Amnesty International Says Prostitution is a human right Meeting in Dublin in August, the self-styled civil libertarians declared laws against prostitution to be human rights abuses, and called for decriminalization of the sex trade. Amnesty activists inhabit a universe where women

make a career choice to sell their bodies, instead of being coerced – physically or by desperate circumstances. What Amnesty is advocating should be called the Pimps and Johns Protection Act.

- 4. California requires some pro-life centers to refer for abortion Under a law signed by California Governor Jerry Brown, which goes into effect this month, pro-life pregnancy resource centers which provide medical services (such as ultra-sounds) will be required to inform clients that there are state-run programs that provide abortions and contraceptives for little or no cost. Naturally, abortion facilities are under no similar obligation (to refer to crisis pregnancy centers). Under the same logic, anti-violence programs could be required to notify participants of the location of local gun shops and shooting ranges.

 Proponents of the California law claim pro-life centers practice deception that women arrive expecting an abortion and leave with information on stages of fetal development and abortion alternatives. Scandalous.
- 5. Woman has Planet Fitness membership revoked for complaining about a man in the ladies' locker room A woman who complained about a man (who says he "identifies as a woman") in the ladies' shower and changing room at the Planet Fitness in Midland, Michigan had her membership revoked for the newest variety of prejudice "transphobia." She was informed that it's the company's



policy to let members use the locker room that comports with their "gender identity." When she warned other women at the club, her membership was

revoked. Planet Fitness advertises itself as a "judgment-free zone," except when it comes to modesty and Judeo-Christian morality.

6. Ashley Madison: Adultery for fun and profit – The Internet service Ashley Madison, where clients advertise for adultery (its motto is "Life is short. Have an affair") suffered a massive security breach when hackers acquired the identifies of 32 million members. Ashley Madison has 39 million users and posted a profit of \$55 million last year, based on \$115 million in sales. Regarding the breach, the media focused on privacy. There was little discussion of what tens of millions cyber-cruising for extra-marital affairs says about the state of marriage continued on page 4



and the family in an anything-goes culture.

7. Ghost homes in Tokyo suburbs – In August, The New York Times reported that in Japan, a nation once known for population density, there are 8 million vacant dwellings. Half have been forsaken completely. Japanese fertility is so far below replacement that in 2014 there were approximately 1 million births and 1.3 million deaths. It also has the most rapidly aging population in the world. Thanks to late marriage, the preference for small families and the failure to form families, the Land of the Rising Sun is quietly setting. Its population is expected to fall by a third over the next 50 years. Japan may be ahead the curve, but other developed nations aren't far behind.

8. Sing and shout your abortion — One of the most disturbing phenomenon of the past year was the growing popularity of the hashtag "#shoutyourabortion." Meant to counter growing pro-life sentiment and outrage over the Planned Parenthood body-part selling scandal, women who've had abortions are urged to celebrate the

death of their unborn children. How far



we've come from Bill Clinton's dictum that abortions should be "legal, safe and rare." Now, for sexual radicals, it's "ubiquitous, celebrated and someone else pays for it."

- **9. California adopts "aid in- dying"** With 10% of the U.S. population, California legalized what proponents euphemistically call aid-in-dying, in October, during a special session of the legislature called to reform that state's Medicaid system. With this approach, advocates were able to short-circuit the legislative process, in particular avoiding hearings and the opportunity to lobby legislators. They also avoided embarrassing questions about abuses in countries like Belgium and the Netherlands. If doctor-assisted suicide is as popular as its advocates claim, why this approach? Why does it have to be smuggled in, like pork-barrel spending, to avoid public scrutiny?
- **10. U.S. State Department pushes gay rights in Africa** According to a story in the December 26 New York Times, "Since 2012, the American government has put more than \$700 million into supporting gay rights groups and causes globally." More that half of that money has focused on sub-Saharan Africa. The article also notes that U.S. involvement has made matters worse, according to activists on both sides of the debate. Given the traditional nature of African society, this is unsurprising.

Once, American liberals said different people were entitled to their own cultures and what they then called cultural imperialism was intrusive and immoral. In the pursuit of gay rights in emerging nations, those ideals have been discarded. For the U.S. cultural elite, now it's "We talk, you listen."

After every World Congress of Families we all say, "That's the best one yet!" And, it's true. Each Congress builds on the previous ones and they each get better and better. I've been asked what I consider the highlights of the WCF IX and what features made it so special. Let me attempt to identify the characteristics that made WCFIX the remarkable event it was.

First, we had an incredible range of wonderful speakers addressing the pressing issues of the day. With 200 of them spread out over 4 days, that's a lot of outstanding speakers every single day. Many people commented that they thought Tuesday was the highlight, while others thought Wednesday was even more memorable; then Thursday topped that and Friday was the incredible finale! We stand firmly and unwaveringly for Judeo-Christian values, and we believe equally strongly in civil discourse and in the power of truth; we welcomed anyone who is willing to listen respectfully and with an open mind.

Fourth and most importantly, at a pivotal time when the US Supreme Court overturned the codified will of the people in 32 States regarding the historic meaning of the nature of marriage with the Obergefell decision, WCF IX moved forward to hold the first World Congress in the United States with an overflow crowd who enjoyed a Congress that, once again, showcased speakers from around the world sharing pro-life, pro-marriage and pro-family values:

Every Georgian child knows this legend: When God created the world, He gave land to each nation. The Georgians were late for the distribution as they were honoring guests at a feast. Having come late, after all the lands were given to all the nations, they asked God to have mercy on them, as they were hosting guests as a sign of His Grace. God forgave the Georgians by giving them the last piece of land, which He had saved for Himself. This is how Georgians came to live in Georgia.

During his visit to Tbilisi in 2005, President George W. Bush called Georgia the "beacon of democracy." Long regarded as the most pro-western of the former Soviet republics, Georgia is no ordinary place. Legendary for its majestic beauty and authentic culture, Georgia has been a legend among travelers. Nobel Prize winning American writer, John Steinbeck, when visiting Soviet Union in 1948, wrote:

"Wherever we had been in Russia... the magical name of Georgia came up constantly. People who had never been there, and who possibly never could go there, spoke of Georgia with a kind of longing and a great admiration. They spoke of Georgians as supermen, as great drinkers, great dancers, great musicians, great workers and lovers. And they spoke of the country in the Caucasus and around the Black Sea as a kind of second heaven. Indeed, we began to believe that most Russians hope that if they live very good and virtuous lives, they will go not to heaven, but to Georgia, when they die."

After he visited Georgia himself, Steinbeck wrote:
"It is a magical place, Georgia, and it becomes
dream-like the moment you have left it. And the people are
magic people. It is true that they have one of the richest and
most beautiful countries in the world, and they live up to it.
And we understood thoroughly now why Russians had
always said to us, 'Until you have seen Georgia, you have
seen nothing.'"

Regarded as the birthplace of wine-making, metallurgy, agriculture and polyphonic singing, having one of the world's 14 original alphabets, and as one of the oldest Christian countries in the world (Christianity became Georgia's state religion in 327 AD), Georgia has so much to offer to its visitors.

Located at the crossroads of Asia and Europe, Georgia has absorbed all of the great cultural influences. When in Georgia, you will be reminded of many of the great cultures you have seen, but you will know, you are in



Georgia.

On one hand, Georgia has been more successful than most of the former Soviet republics in modernizing (you will first encounter this in the ease of entry at Tbilisi Airport) and at democratic reform, on the other, Georgia is under a massive invasion of George Soros-sponsored Western NGOs, which are making it their business to interfere and influence the policy of this sovereign state. Tbilisi 2016 could begin the process of rolling back Cultural Marxism across the continent.

Novae Terrae Releases International Education Index

Since 2013, Novae Terrae Foundation (a World Congress of Families Partner) has worked with the International Organization for the Right to Education and for Freedom of Education (OIDEL) - an NGO with consultative status at the United Nations, UNESCO and the Council of Europe - to draw up an independent global Freedom of Education Index (including the rights of parents). In September 2014, the Novae Terrae Foundation and OIDEL set up a permanent group of international experts (the Socrates Group), which periodically comes together to examine issues and best practices in countries around the world regarding freedom of education and respect for the rights of parents.

Starting from the provisions of Article 13 of the International Covenant on Economic, Social and Cultural Rights, the Global Index on Freedom of Education provides worldwide data on the respect for and promotion of this fundamental right, and of policies to ensure freedom of education at the national and regional level.

The Index consists of the following:

· Constitutional and legislative provisions relating to parents' freedom to choose the education for

their children. including homeschooling:

The global Index can be an important tool for periodically analysing the evolution of national policies as well as respect and promotion of the right to freedom of education (Council of Europe, 2012) at the international level.

Bishop Emmanuel Adetoyese Badejo

Bishop Badejo was born in 1961, the sixth of seven children. He entered primary school at the age of four and went to minor seminary by age 9. He exhibited uncommon musical, artistic and intellectual abilities through minor seminary and the SS Peter and Paul Major Seminary, Ibadan where he studied philosophy.



Bishop Badejo studied theology in Rome and by 1984, at

age 23, completed the studies for priestly ordination and was ordained in 1986.

In 1989 he won the scholarship of the Catholic Union of the Press (UCIP) as the best youth journalist in Nigeria and was sponsored to the organization's World Congress in Ruhpolding, Germany. He returned to Rome in 1992 for a Licentiate in Pastoral Communications at the Salesian University and travelled all over Europe for various conferences, returning to Nigeria to work for the Catholic Bishops Conference of Nigeria, (CBCN), as Director of Communications for 8 years. During this time, he coordinated and recorded musical tapes and audio and video productions addressing themes related to Faith, Family, HIV/Aids and Youth.

On a sabbatical in the United States, while doing research on film and spirituality, he was appointed Bishop of the Diocese of Oyo in Nigeria in 2007.

Bishop Badejo believes strongly in the limitless capacities of a child's mind and so tries to learn from children because they express themselves with minimum filters and inhibitions. He also admires the enthusiasm, hope and generosity of young people even in desperate conditions. This enriches his total belief in the sanctity of life and the inviolability of the human right to live with dignity. For these reasons, he often speaks from the pulpit and in writing, on the inability of leaders in the political, social and religious arena to positively harness the creativity and generosity of youth and use these transforming qualities to create a better world especially in Africa.

The Bishop works extensively on supporting families and forming pastoral agents for marriage and family issues. He helps to organize conferences and meetings on pro-life issues and family formation and advocacy within

Besides planning and executing programs that enhance public perception of the school, organizing events and activities and managing communication locally and internationally, Tinatin was also involved in communication with school departments, coordinating tasks and monitoring the implementation process.

Tinatin has been a pro-family advocate actively involved with Georgian Demographic Society, the principal NGO that works with Georgian government to promote a pro-life agenda and support improvement of extremely grave demographic situation in Georgia.

With special emphases on education and pension-system
